

HAZARDOUS / PROHIBITED ITEMS NOT ACCEPTED FOR SHIPPING (Air and Sea), STORAGE or by CUSTOMS

Following is a list of items that are prohibited as part of a household goods and personal effects shipment (Air & Sea), are not covered by insurance, nor is the damage caused by these items covered and/or are not allowed to be imported in the country of destination. If you are in doubt about items that are not listed, please don't ship or ask your move coordinator to verify.

1. Flammables

- Paints, Varnish (Varnish Removers) or Wool Oil Stains
- Petro-chemical Based Garden Sprays
- Charcoal Briquettes
- Lighter Fluid/Lighters
- Propane/Butane/Gasoline tanks
- Signal Flares
- Matches

2. <u>Combustible Liquids</u>

- Lubricants (Motor Oils)
- Anti-Freeze Compounds
- Alcohols (e.g. Rubbing)
- Fertilizers

3. Compressed Gases

- Aerosol Cans
- Fire Extinguishers
- Scuba Diving Tanks (unless purged)
- BBQ gas tanks

4. Corrosives

- Bleach, Solvents or toxic/corrosives substances, etc.
- Drain Cleaner/Oven cleaner
- Batteries (Wet or Dry)
- Acids
- Photographic Acids Used to Develop Film
- Water Purifying Agents Used in Swimming Pools

5. Explosives

- Small Arms Ammunition
- Mace, teargas, pepper spray, etc.
- Fireworks
- Flash Bulbs



6. <u>Live Plants, Live Animals/Pets, Seeds, Fresh Fruits or Flowers, Pet Food, Meat, other foods of any kind, untreated wood like fire wood and lumber, building materials.</u>

Please be aware that the above items cannot be transported with your household goods. Food items will create a red flag for customs resulting is intrusive inspections, possible damage and significant additional cost due to port storage charges and inspection fees.

7. Prohibited Items

- Pornographic Material
- Alcohol of any kind

Shipping wine collections will require employer's approval. If approved, wine should be send separately and often requires an import license and a detailed inventory

- Narcotics and Drugs
- Unprocessed furs and skins
- Fire arms, guns
- Hoverboards

8. Valuables

The following valuable items may not be shipped and must be removed prior to the packers' arrival.

- Jewelry
- Legal Documents
- Cash / Money / Currency of all kinds
- Watches
- Trading Stamps
- Coin Collections
- Furs
- Other items and collections of high value
